No Bidder may withdraw his bid for a period of thirty (30) days after the bid opening date.

Bids received more than ninety-six (96) hours before the time set for receiving bids as well as bids received after the time set for receipt of bids will not be considered, and will be returned unopened. The Board of County Commissioners of Grant County, Oklahoma reserve the right to reject any or all bids and to waive formalities or minor irregularities in any bid, and to determine and select the lowest and best bid.
