MINUTES OF BOCC REGULAR MEETING

Board of Commissioners of Grant County, Oklahoma (BOCC) held a regular meeting **Monday, February 13, 2023**, at 9:00 am. Notice of the Meeting, including agenda, was posted at both entrances of the Grant County Courthouse, Medford, OK, Friday, February 10, 2023, by 9:00 am. in accordance with Title 25, §301-314 O.S.

Stinson called the meeting to order at 9:00 a.m. After roll call, a quorum was acknowledged. Present were Steve Stinson, Craig A Fredrick, and Max L Hess. Also present were Alexandra Brittain and Tom and Sabrina Smith from ProActive Air Solutions. Penny Huff entered the meeting at 9:06 a.m. and Jody Helm entered briefly at 10:16 a.m. Teleconferencing was enabled to comply with the Open Meetings Act.

Tom and Sabrina Smith with ProActive Air Solutions did a presentation for an active filtration system for the courthouse. Active filtration can disinfect the air within one minute and works 24/7. In-duct units and portable units are available. The cost is between \$1.25 to \$1.50 per sq. foot installation with light and filter maintenance each year being a separate, additional cost. ProActive Air Solutions currently does business with multiple Oklahoma counties and school districts. Information packets were left with each commissioner for any follow-up questions and possible quotes.
