## MINUTES OF BOCC REGULAR MEETING

The Board of Commissioners of Grant County, Oklahoma (BOCC) held a regular meeting **Monday, March 18, 2024,** at 9:00 am. Notice of the Meeting, including agenda, was posted at both entrances of the Grant County Courthouse, Medford, OK, Friday, March 15, 2024, by 9:00 am. in accordance with Title 25, §301-314 O.S.

Fredrick called the meeting to order at 9:00 a.m. After roll call, a quorum was acknowledged. Present were Craig A Fredrick, Max L Hess, and Steve Stinson. Cindy Pratt, Penny Huff, and Mike Walls of Warren Cat were also present. Scott Dawson was present until 9:30 a.m. Dea Mandeville, Kacy Wallace, and Jim Shepherd entered at 9:23 a.m. Teleconferencing was enabled to comply with the Open Meetings Act. All commissioners used their signature stamps.

In agreement with OPEH&W, AF would assist and/or provide the following: Optional supplemental benefits for employees • Assistance with employee annual open enrollment in the HEART system (Health Ins annual renewal) • Provide annual IRS required 1094C form for employee.
