## INTERLOCAL AGREEMENT

This agreement for services ("Agreement" herein) is made and entered into under the authority of 74 O.S. 1008 (Interlocal Cooperation Act) by and between the Sheriff of Canadian County, Oklahoma and the Canadian County Board of Commissioners, party of the first part, (Herein after called "Canadian County") and the Sheriff of Grant County, Oklahoma and the Grant County Board of Commissioners, party of the second part, (Herein after called "Grant County").

Whereas, Canadian County has an excess of inmates who are being held in the Canadian County Detention Center and has a need for inmate housing and Grant County currently has housing available for inmates at the Grant County Jail. Therefore the purpose of this agreement is to enable Canadian County to utilize county jail bed space at Grant County, to house prisoners sentenced to incarceration or awaiting sentencing.

Upon said approval, Grant County, agrees to provide housing and board for inmates from Canadian County.

It is understood that the inmates provided by Canadian County will be ones who have neither a violent history nor medical problems which would entail additional expenses for Grant County. In the event that there should be additional expense, Canadian County agrees to pay such expense.

Canadian County agrees to pay Grant County at the rate of \$18.00 per inmate per day.

Canadian County shall be responsible for all costs and expenses for transportation of inmates and medical treatment.

Grant County shall maintain a record of the number of Canadian County inmates housed and the number of days per inmate per month.

Grant County will on the 1<sup>st</sup> day of each month send an invoice to Canadian County for services provided for the previous month.

**This agreement shall remain in effect from July 1, 2017 to June 30, 2018.**

This agreement may be terminated following oral or written discussion between the parties in which one of the parties wish to terminate the agreement or by the incapability of the holding facility at the Grant County Jail to continue to house inmates due to fire, flood, power failure, or other act of nature. In the event that either party wish to terminate the agreement, written notice shall be mailed, by

certified mail, return receipt requested, or hand delivered to the other party. Who in turn will endorse the notice and have signature notarized and return to sender.

**From the date that the notice is received, Canadian County will have 30 days to have any of their inmates in Grant County Jail picked up and transferred from Grant County. Canadian County shall be responsible for paying daily cost of housing inmates up until the day they are moved from Grant County.**


